- Appointments shall be made, on contract basis, Under "The Contract Appointment Policy, 2004" initially for a period of 03 years extendable subject to good performance.
- Complete application alongwith attested copies of all educational certificates (like Matric. F.Sc. etc.) /

degrees / diplomas, copy of domicile, valid CNIC, work experience certificates (if any) and 02 latest passport size photographs must be submitted in the office of Medical Superintendent, Nishtar Hospital, Multan.

- In case of "o" level & "A" level, equivalence certificate must also be submitted.
- 6. Applicants must present original documents at the time of interview.
- Age relaxation in upper age limit shall be granted as per rule.
- Quotas shall be observed as per Recruitment Policy, 2022.
- Recruitment shall be made strictly on merit in accordance with "The Contract Appointment Policy, 2004/Recruitment Policy, 2022" and instructions issued from time to time by the Government of the Punjab.
