<b>Post Project Manager (PPS-9)</b>	
<b>Qualification</b>	The candidate should have 16 Years of university degree in Environmental Sciences / Project Management / MBBS or any other relevant field recognized by HEC.
<b>Experience</b>	He/she must have at least 8 years’ first-hand experience in the area of public health especially related to water, sanitation, health and hygiene including experience of handling foreign funded or Government projects.
<b>Age Limit</b>	30-45 years plus five (5) years general relaxation in upper age limit.
