- The Special Selection Board shall make selection strictly on merit for posts BS-16 and above.
- Two (02) set of attested photocopies of following documents is required to submit along with the application.
 - Matriculation Certificate, showing date of birth and in case of 'O' Level, equivalent certificate from Inter Board Committee of Chairman, Islamabad and date of birth given in school leaving certificate.
 - Intermediate Certificate / 'A' Level along with certificate of equivalent qualification.
 - Degree and Detail marks of MBBS (1st to final profs.) duly issued by Controller of Examinations showing total/obtained marks and percentages or equivalent qualification + Degree/D.M.C of postgraduate qualifications & experience certificate.
 - Domicile certificate of relevant district of Province of Punjab issued on or before the closing date.
 - Valid C.N.I.C.
 - Disability certificate should be attached duly issued by the Competent Authority, if applicable.
 - Two passport size photograph.
 - Foreign qualification(s) must be recognized by P.M.D.C (PMC) and equivalent qualification certificate from (QEDC) of Health Department.
 - Valid PM&DC/PMC registration certificate showing all medical degrees/postgraduate qualifications therein.
 - 02-sets of photocopies of research work published in a standard medical journal recognized by PMDC (PMC).
