Note:-

- i) No. of positions may be increased or decreased as per requirement.
- ii) Females are encouraged to apply and will be given preference.
- iii) About 20% additional workforce will also be called for training, while for field work final selection of candidates will be performance based, during the training session.
- iv) No. of days of field work may increased or decreased depending upon the work load. Selection will be made on merit basis, and shall be purely temporary on daily wage /work basis and there will be no right of being permanent whatsoever.
- v) Final decision of the Authority shall not be challenged in any court/ forum.
- vi) Authority may terminate the contract of any candidate at any stage without any reason.
- vii) Selected/ Short listed candidates will be informed telephonically to participate in training.
- viii) Candidates who get training and intentionally do not join field work when needed, shall not be paid any remuneration at all.
- ix) Successful candidates shall sign an agreement with BoS for their availability and completion of the task.
- x) Absence/ poor performance shall lead to termination of contract.
- xi) During the course of this purely temporary assignment, Department shall not be liable to pay any health/ risk insurance to health/ life of any candidate.
